ASSESSMENT INFORMATION

Did you remember that if your assessments are not paid, and you have a fire at your home, the State of Oklahoma will send you a bill? That is correct. By keeping your assessments paid up-to-date, you will not have to pay for a fire truck to assist you in case of a fire or a medical call to your home.

Ten per cent of assessments collected annually are sent to the fire department. If you have a fire, they check with us to see if you have paid your assessments. If you have paid, you are not billed. If you have NOT paid, you will be billed by the State of Oklahoma.

Assessments are due in January. You will be sent a notice when they are due along with the amount owed.

ADDRESSES NEEDED

We are preparing the end of the year Assessment letters for each homeowner. We do not have the proper mailing address for many of you. The post office will no longer deliver to the old HC67 address; therefore, we are asking that you please check with us to be sure we have your correct mailing address.

If your letter is returned to us that is wasted postage and it could end up costing you a late fee in the long run.

Also if there is an emergency or a fire at your home and they are looking for the 911 address, it can certainly delay assistance to you.

Please give us your address. If you cannot call us, Email us at the address at the top of newsletter or write us.
